

## **NGPD Police Blotter for week of 3/24/24 to 3/30/24**

Officers responded to 29 weather related incidents throughout the day in addition to what is listed here.

In that case, the victim alleged that Rosenthal had called them which violated an Order of Protection. She was charged with Criminal Contempt 2<sup>nd</sup> degree, a misdemeanor. She was arraigned at North Greenbush Town Court and was released to monitoring by Probation. *Investigation and arrest by Officers Verardi and Gray*

5:31 PM- **Arrest**- Jeremy Roberts, of East Greenbush, was taken into custody on an outstanding arrest warrant at North Greenbush Town Court as he arrived to appear on separate charges. The warrant stemmed from a complaint on March 25<sup>th</sup>, 2024 that he had violated an Order of Protection by posting material on social media which was prohibited by such order. He was charged with Criminal Contempt 2<sup>nd</sup> degree, a misdemeanor, and arraigned at North Greenbush Town Court. He was remanded to Rensselaer County Jail in lieu of \$25,000 bail and is to return to court at a later date. *Investigation by Officers Gray and Verardi. Arrest by Officers Gray, Schrader, and Detective Walsh*

10:44 PM- **Welfare Check**- In the 100 block of Bloomingrove Dr. Caller reported getting a phone call from a resident who was looking for a ride to leave the house as there was an Order of Protection being violated. Caller reported that there was yelling in the background during that call. Officers met with the subject in question who denied needing any assistance. *Officers Gray, Verardi, and Schrader*

11:10 PM- **Welfare Check**- In the 100 block of Bloomingrove Dr. Caller requested officers return to the residence from the previous call as they had concerns about the individual there. Officers met with the residents of the home again and determined that the information being reported was false and possibly being done so maliciously. *Officers Cooper and Giddings*
