

NGPD Police Blotter for week of 10/12/25 to 10/18/25

EMS calls, Burglar Alarms, Fire Alarms, Department Details, Investigation Follow Ups, Hazardous Situations, Vehicle Lock Outs, Reckless Driving complaints, 911 Hang Ups, Animal Problems not resulting in injury, Suspicious Vehicles and Persons not resulting in an arrest, and Property Damage Auto Accidents/Traffic Stops not resulting in an arrest are excluded from this list.

2:21 PM- **Assist Other Agency-** At Target in East Greenbush. EGPD requested assistance with a larceny in progress. *Officer Verardi*

3:15 PM- **Menacing-** At Town Hall. A 14-year-old male from North Greenbush was taken into custody at the station following an investigation into a complaint that he had threatened another youth with a knife at the playground. The incident began at McDonald's where the male started harassing the victim and calling him racial slurs. The male then followed the victim and their friends to Town Hall where the male continued to call the victim names and racial slurs.

Witnesses indicated that the male suddenly pulled a knife from his backpack and threatened to kill the victim and started towards the victim but witnesses held him back. He was charged with Menacing 3rd degree as a Hate Crime, Criminal Possession of a Weapon with Intent to Use 4th degree, Aggravated Harassment 2nd degree, and Unlawful Possession of a Weapon by a Person >16 Years of Age, all misdemeanors. He was released to a parent and is to appear in Rensselaer County Family Court at a later date. The male was also advised not to return to Town Hall property. *Officers Valenti and Gray*

3:45 AM- **Arrest-** Naeoshah White, of Troy, was taken into custody during a traffic stop in the RPI Tech Park when it was discovered that she had several suspensions and revocations in effect despite only having an ID, and that the vehicle's registration was suspended. She was charged with Aggravated Unlicensed Operation 2nd degree, a misdemeanor, Operation Without Insurance, and several equipment infractions. Castro was found to have an arrest warrant out of Bergen County Sheriffs Office in New Jersey which had extradition throughout the United States. NYSP responded to the station to provide translation services. She was charged with Grand Larceny 3rd degree, a felony, Conspiracy 5th degree, a misdemeanor, and Fugitive From Justice. She was arraigned at North Greenbush Town Court and remanded to Rensselaer County Jail pending extradition to New Jersey. She is to return to that court at a later date for the other charges. *Sergeant Bourdeau and Officer Gray*

4:30 PM- **Arrest**- Julio Morales, of Passaic, NJ, was taken into custody with Rosa Castro. He was charged with Grand Larceny 3rd degree, a felony, and Conspiracy 5th degree, a misdemeanor. He was arraigned at North Greenbush Town Court and released to return to that court at a later date. *Sergeant Bourdeau and Officer Gray*
