His true identity was discovered only after he had been released from custody and a warrant was obtained. He was charged with Identity Theft 1st degree, Forgery 2nd degree, Offering a False Instrument 1st degree, all felonies, and Criminal Impersonation 2nd degree, a misdemeanor. He was also charged again for the original Petit Larceny, a misdemeanor. He was arraigned at North Greenbush Town Court and remanded back to the custody of ACJ on \$1 bail. He is to return to that court at a later date. *Officers Cox and Verardi*
