Officer stopped Stallworth for driving with no headlights or taillights on. Upon speaking with Stallworth, the officer observed indicators that Stallworth was under the influence and had a 1-year-old child in the back seat. Officers administered field sobriety tests which Stallworth failed. Another adult was in the vehicle and the child was left with them while Stallworth was taken into custody. A subsequent breath test yielded a result of .09% BAC. He was charged with Aggravated DWI (child passenger), a felony, Endangering the Welfare of a Child, Driving While Intoxicated, Operation with a BAC >.08%, Operation While Registration Suspended, all

misdemeanors, and Operating Without Headlights, an infraction. He was released to appear in court at a later date. Officers Pollay and Clemenzi

In that case, it is alleged that Clair had intentionally rammed his vehicle into his spouse's vehicle during an argument and caused serious damage. He was charged with Criminal Mischief 3rd degree, a felony, and released to appear in court at a later date.

Upon speaking with him, officers observed indicators that he may have been under the influence. Field sobriety tests were administered, which he failed. A subsequent breath test yielded a result of .12% BAC. He was charged with Driving While Intoxicated, Operation with a BAC >.08%, both misdemeanors, Insufficient/ No Taillights, and Unregistered Vehicle, both infractions. He was released to appear in court at a later date. *Officers Pollay and Clemenzi*
