5:48 PM- **Arrest**- Kipp Vanloan, of North Greenbush, was taken into custody for DWI under Leandra's Law during an investigation into a property damage auto accident on Sharpe Rd. The collision had occurred in the S-turns on Sharpe Rd. but the striking vehicle had fled the scene. The other party followed the vehicle to an address where a child had exited the vehicle and went into the residence. Vanloan was found to be the driver of that striking vehicle. Officers observed indicators that Vanloan was under the influence and administered field sobriety tests, which Vanloan failed. The child was identified as a 6-year-old family member and was confirmed not to have been hurt in the crash. A subsequent breath test on Vanloan yielded a result of .10% BAC. He was charged with Aggravated DWI- Child Passenger, a felony, Driving While Intoxicated, a misdemeanor, Uninsured Vehicle, and Failed to Use Designated Lane, both infractions. He was released to appear in court at a later date. *Sergeant Bourdeau and Officer Jukes*

7:50 PM- **Arrest**- Joshua Bailey, of North Greenbush, was taken into custody at Vanderheyden during an investigation into a disturbance. Staff reported that Bailey had been attacking staff and other residents. He was charged with two counts of Attempted Assault 3rd degree and 2 counts of Harassment 1st degree, both misdemeanors. He was released and turned back over to staff. He is to appear in court at a later date. *Officer Jukes and Sergeant Bourdeau*
