12:40 AM- **Arrest-** Joshua Delamater, of Castleton, was taken into custody during a traffic stop on Washington Ave. Ext. and charged with DWI. Delamater was stopped for speeding and, upon interview, the officer observed indicators that he was under the influence. Field sobriety tests were administered, which Delamater failed, and a subsequent breath test yielded a result of .12% BAC. He was charged with Driving While Intoxicated, Operation With a BAC >.08%, both misdemeanors, Speed in Zone, and Uninspected Vehicle, both infractions. He was released to appear in court at a later date. *Officer Clemenzi and Sergeant Peasley*

1:13 PM- **Larceny-** At Raizada Fast Food Express. Staff reported a driver that had pumped fuel and left without paying. Officer located the subject and found that there was an error with the credit card reader. *Officer Catlin*

3:01 AM- **Arrest-** Ebuela Demetrio, of Albany, was taken into custody during a traffic stop on North Greenbush Rd. when it was discovered that he only had a Learner's Permit which had several suspensions. He was charged with Aggravated Unlicensed Operation 3rd degree, a misdemeanor, Unlicensed Operation, and Inadequate Lights, both infractions. He was released to appear in court at a later date. *Officers Pollay and Clemenzi*

She was charged with Operation While Registration Suspended, a misdemeanor, Operation Without Insurance, and Uninspected Vehicle, both infractions. 3:28 PM- **Arrest-** Eric Mayrell, of Albany, was taken into custody on an active arrest warrant at Albany County Jail where he was being held on unrelated charges. The warrant stemmed from a June 17th, 2025 incident at Community Resource Federal Credit Union where a male had deposited 4 counterfeit money orders, each in the amount of \$1,000. A few days later, the male had withdrawn \$3,999 from that account before the forgery was discovered. The investigation led to Mayrell being identified as the male involved. He was charged with Grand Larceny 3rd degree and Criminal Possession of a Forged Instrument 2nd degree, both felonies. He was arraigned at North Greenbush Town Court and remanded back to the custody of ACJ on \$1 bail as he was being held on several unrelated charges, including an extraditable warrant out of Texas. *Investigation by Detective Walsh. Arrest by Officer Gray*

6:23 PM- **Assault-** At the station. A citizen wished to report an assault that had occurred on Jordan Rd. earlier in the evening. *Officer Schrader and Sergeant Bourdeau*

12:39 AM- **Arrest-** Phillip Bassett, of Albany, was taken into custody during a traffic stop on I-90 Exit 8 when it was discovered that his driver's license was suspended. He had been stopped

for driving the wrong way on the exit ramp. He was charged with Aggravated Unlicensed Operation 3rd degree, a misdemeanor, and Driving the Wrong Way, an infraction. He was released to appear in court at a later date. *Sergeant Peasley and Officer Pollay*

Hatch was stopped for driving without headlights and, upon interview, the officer observed indicators that he was under the influence. Field sobriety tests were conducted, which Hatch failed. A subsequent breath test yielded a result of .30% BAC. He was charged with Driving While Intoxicated, Aggravated DWI- BAC >.18%, both misdemeanors, Open Container in a Vehicle, and Failed to Use Headlights, both infractions. He was processed and released but taken by NGAA to the hospital for acute intoxication. He is to appear in court at a later date. *Officer Clemenzi and Sergeant Peasley*

8:48 PM- **Welfare Check**- On Zelenke Dr. Caller requested officers check on a family member who they had not been able to reach by phone for several hours. Officers located the family member and found they were okay. *Officers Gray and Valenti*

Officers were able to rouse the driver, now known to be Goyette, and get him to put the vehicle in park. During their interview, officers observed indicators that he was under the influence. Field sobriety tests were administered which Goyette failed. A subsequent breath test yielded a result of 0% BAC, leading officers to conclude he was under the influence of a different substance. Samples were secured for testing to determine what substances were present. He was charged with Driving While Ability Impaired by Drugs, a misdemeanor, and Parking on Pavement, an infraction. He was released to appear in court at a later date. *Officers Cox and Gray*
