

## NGPD Police Blotter for week of 1/4/26 to 1/10/26

*EMS calls, Burglar Alarms, Fire Alarms, Department Details, Investigation Follow Ups, Hazardous Situations, Vehicle Lock Outs, Reckless Driving complaints, 911 Hang Ups, Animal Problems not resulting in injury, Suspicious Vehicles and Persons not resulting in an arrest, and Property Damage Auto Accidents/Traffic Stops not resulting in an arrest are excluded from this list.*

3:42 AM- **Arrest**- James Case, of Troy, was taken into custody during a traffic stop on Winter St. Ext. and charged with Driving While Ability Impaired by Drugs and drug charges. Officer stopped Case for driving without headlights and, upon interviewing him, observed indicators that he was under the influence. Field Sobriety tests were administered, which Case failed. During a search of Case, officer located about 1 gram of a white, powdery substance believed to be cocaine. A Watervliet PD officer assisted as a Drug Recognition Expert to determine what type of drugs Case was under the influence of. He was charged with Criminal Possession of a Controlled Substance 4<sup>th</sup> degree, a felony, Driving While Ability Impaired by Drugs, Criminal Use of Drug Paraphernalia, both misdemeanors, and equipment infractions. He was arraigned at North Greenbush Town Court and released to return at a later date. *Officer Clemenzi and Sergeant Peasley*

2:11 PM- **Disturbance**- At Hannaford. Caller reported that another vehicle was refusing to let them back out of their parking space. Officers interviewed both parties and it seemed they did not know each other. All parties were advised. *Officers Jukes and Valenti*

3:40 PM- **Emotionally Distressed Person**- In the 100 block of North Greenbush Rd. Caller reported that a family member had threatened to harm themselves. Officers located the subject who agreed they wanted help. Officers transported the subject to Samaritan Hospital for a mental health evaluation. *Officers Verardi and Gray*

11:03 PM- **Welfare Check**- On Apple Tree Ln. Caller was not clear about why they were calling but sounded to be in need of assistance. Officer recognized the caller from the little information given and located him at a residence in the area. Caller was found to be having a mental health issue but was not in crisis. *Officer Gray*

**2:21 AM- Arrest-** Lucas Kiablick, of Austerlitz, was taken into custody during a traffic stop on State Route 43 when it was discovered that his driver's license was suspended, he was in possession of drugs, and he was wanted by Troy PD and NYSP. Officer stopped Kiablick for having an obstructed license plate and an expired vehicle inspection. Upon a search of the vehicle, officers discovered less than 1 gram of a white, powdery substance believed to be heroin along with glass pipes and accessories. Kiablick was charged with Aggravated Unlicensed Operation 3<sup>rd</sup> degree, Criminal Possession of a Controlled Substance 7<sup>th</sup> degree, Criminal Use of Drug Paraphernalia 2<sup>nd</sup> degree, all misdemeanors, Uninspected Vehicle, and other equipment infractions. He was turned over to the custody of Troy PD on their warrant and is to appear in court at a later date. *Officers Clemenzi and Pollay*

**2:21 AM- Arrest-** Alesha Proskin, of Amsterdam, was a passenger in Kiablick's vehicle and was also found to have a warrant out of Troy PD. She was also charged with possession of white, powdery substance that was in the vehicle. She was charged with Criminal Possession of a Controlled Substance 7<sup>th</sup> degree and Criminal Use of Drug Paraphernalia 2<sup>nd</sup> degree, both misdemeanors. She was turned over to the custody of Troy PD on their warrant and is to appear in court at a later date. *Officers Clemenzi and Pollay*

**3:15 PM- Arrest-** Marilyn Saldana, of Rensselaer, turned herself in on an active arrest warrant stemming from a shoplifting incident at Ulta Beauty on October 30<sup>th</sup>, 2025. In that case, staff reported that two females had stolen \$281 worth of merchandise. Saldana was charged with Petit Larceny and Conspiracy 6<sup>th</sup> degree, both misdemeanors, and released to appear in court at later date. The other female had been arrested two weeks prior for her role in this incident.

Caller reported a 13-year-old student on their way to school in a transport SUV was out of control, had punched the driver in the head several times while they were driving and tried grabbing the steering wheel to swerve the vehicle off the road. Officers arrived and detained the subject after a brief struggle. It was determined that the youth was in crisis and they were taken to Samaritan Hospital for a mental health evaluation. *Officers Catlin and Valenti*

**12:22 PM- Arrest-** Harry Chriss, of Waterford, was taken into custody in the 100 block of Main Ave. during an investigation into a harassment. Caller reported that Chriss was at the caller's workplace despite having an Order of Protection against him. Caller stated he had been told several times to leave but refused and threatened to damage property inside the business. Officers arrived to find that the subject had left the building but they could see him in the Stewart's Shop parking lot. When officers approached him, they discovered that he had stolen beer from Stewart's but they declined charges. Chriss was charged with Criminal Contempt 1<sup>st</sup> degree, a felony, and arraigned at North Greenbush Town Court. He was released to monitoring by Rensselaer County Probation and is to return to that court at a later date. Chriss was turned over to Rensselaer County Sheriff's Office on an active warrant. *Officers Catlin and Valenti*

**4:20 PM- Domestic Dispute-** In Van Rensselaer Square. Several calls were received regarding a male yelling that a female had stolen his vehicle and phone. Officers arrived to find that both parties had left in separate vehicles. The area was checked but they were not located nor did either party call to report the incident. *Officers Gray and Verardi*

**2:12 AM- Emotionally Distressed Person-** On Northview Ave. Caller reported events that could not have happened and they had tried to report before. Officer stopped Myers for a window tint infraction and, upon interview, observed indicators that he was impaired. Field sobriety tests were administered which Myers failed. A subsequent breath test yielded a result of .10% BAC. He was charged with Driving While Intoxicated, Operation with a BAC  $> .08\%$ , both misdemeanors, and two window tint infractions. He was released to appear in court at a later date. *Officers Clemenzi, Pollay, and Sergeant Peasley*

2:29 PM- **Larceny**- At Ulta Beauty. Staff reported a male that was in the store and known to steal. The subject left the store prior to officers arriving but it was determined that he hadn't taken anything this time. *Officers Valenti, Cox, Gervais, and Detective Walsh*
