In that case, officers responded to North Greenbush Rd. for a report of a reckless driver. Upon locating the vehicle and attempting to stop it, the driver fled at a high rate of speed onto I-90. Officers recognized O'Connell as the driver from previous incidents. On December 29th, as the officers made contact with him at his residence, he fled on foot but was captured a short distance away. He was charged with Obstructing Governmental Administration 2nd degree, Unlawful Fleeing in a Motor Vehicle 3rd degree, Reckless Driving, all misdemeanors, and multiple moving infractions. 3:25 AM- **Ronnie Franklin**, of Cohoes, was taken into custody during a traffic stop on North Greenbush Rd. when it was discovered he was driving with an ID Only which had 9 separate active suspensions.
