2:54 AM- **Arrest**- Timothy Marbot, of North Greenbush, was taken into custody during a traffic stop on North Greenbush Rd. and charged with Driving While Ability Impaired by Drugs. Officer stopped him for driving into the oncoming lane and, upon interviewing him, observed indicators that he was under the influence. Field sobriety tests were administered, which Marbot failed, and he refused chemical testing. He was also found to have a suspended driver's license and prior convictions for driving while impaired which escalated this new charge. Further, the vehicle he was driving was not equipped with an ignition interlock device, which had been court ordered. He was charged with Driving While Ability Impaired by Drugs: 2 Prior Convictions, Aggravated Unlicensed Operation 1st degree, both felonies, Circumventing an Ignition Interlock Device, a misdemeanor, a lane violation and Uninspected Vehicle, both infractions. He was arraigned at North Greenbush Town Court and remanded to Rensselaer County Jail without bail. He is to return to that court at a later date. *Officers Clemenzi and Pollay*

9:43 AM- **Welfare Check**- At Bloomingrove Senior Housing. Caller reported a subject that had been sleeping in a car for a couple of hours. Officers located the subject and found they were a resident. Officers assisted getting the subject to their apartment. *Sergeant Deeb and Officer Cox*

The card was subsequently used for about \$1,240 in ATM withdrawals and online purchases. May was charged 2 counts of Grand Larceny 4th degree and 1 count of Criminal Possession of Stolen Property 4th degree, both felonies. He was arraigned at North Greenbush Town Court and remanded back to the custody of ACJ on \$1 bail. He is to return to that court at a later date.
